fee for organizing of container repair in case of container malfunction;

information services along the whole route;

Forwarder's remuneration.



Special rates for the transportation of empty containers along the route Brest - Altynkol are applied subject to the loading only of empty containers in an amount 31-36 containers onto 31 platforms of the Forwarder by the Client independently at the Malaszewicze station of the Polish railway, subject to the mandatory condition of loading empty containers onto the fitting platforms of the Forwarder with the doors facing outwards.

The reloading of empty containers to 1435mm gauge wagons after completion of transportation is carried out according to SMGS rules on the territory of the receiving party (in the China).

The transportations of empty containers along the route Brest - Altynkol are not taken into account for application the special rate on the routes U WEST (China-Europe).
